- All items must be clean and in good condition. We only select items we think can be sold and price them as fairly as possible.
- Arrangements may be made to pick-up certain large items depending on their location. Please **call** for more information.
- Consignors are responsible for tracking their consignments and checking to see if any have sold. You should wait two weeks before checking consignment status.
- Sales proceeds are split 50/50 between consignor and Second Home.
- Consignors who wish to insure their consignments against loss due to fire, theft, or other damage may do so at their own expense. Second Home provides no coverage for such losses.
- Consignment period is 60 days per item. Any unsold items remaining after 30 days are subject to a 25% price reduction. All unsold items must be claimed by consignor before 60 days have expired. After that they become the property of Second Home. Consignor may remove unsold items any time during the consignment period.
- Any money not collected by the consignor within one year of the date an item was consigned is forfeit and becomes the property of Second Home.
- The agreement shall also apply to any future consigned items until such time as a new or updated agreement is signed with the consignor.

**Terms:** Consignor will receive 50% after the sale of the consigned merchandise. This consignment agreement is for 60 days. After 30 days, the ticketed price is subject to a 25% reduction. Consignor may pick up unsold items any time before 60 day consignment period expires. All unsold items not picked up after 60 days are subject to donation.

Consignors please note, that, as equal partners, both you and Second Home would like to sell every item for the maximum amount possible, but we also attempt to price items so they will sell within 30 days.

IT IS THE CONSIGNOR'S RESPONSIBILITY TO CHECK WITH US REGARDING SOLD MERCHANDISE AND TO COLLECT ANY MONEY DUE. Any money not collected by the consignor within one year of the original consignment date will be forfeited, and said money becomes property of Second Home.

It is also the consignor's responsibility to obtain insurance coverage against loss due to Fire, theft or other damage should they wish to have their consignments insured.

All unsold merchandise not picked up by the consignor before the end of the 60 day consignment period becomes the property of Second Home.

This agreement shall remain in effect for all future consignments until such time as a new or revised agreement is made with consignor.
